## INAUGURAL CEREMONY

As the Researcher's test progressed, other team members convened for the Memorial Exchange. Each team was invited to the podium to exchange memorials with their opponents. The day culminated with this thoughtful exchange of memorials, marking a significant moment in the competition.

## QUARTER FINAL ROUND

From the pool of 18 teams, the top-performing 8 teams, distinguished by their outstanding scores, earned qualification for the Quarter Final Round, which adopted a knockout format. The pairing of teams for the Quarter Final Round was executed through a power matchup system, followed by a draw of lots and an exchange of memorials.
